Important information from TASSO e.V.



The following information provides an overview of the free registration of your pet in our database (Section I). Detailed information on data protection can be found in our privacy policy listed below this text (Section II).

I. General information about the free registration of your pet

Registration

1. Registering your pet with the TASSO e.V. pet register is free of charge. There are no follow-up costs. This also applies to all other services. TASSO e.V. finances its animal welfare work through voluntary donations. To give pet owners the opportunity to support TASSO e.V.'s diverse animal welfare efforts, a bank transfer form is usually included in written correspondence. Online donations are also possible at any time via the TASSO website.

2. The data provided to TASSO e.V. is subject to data protection regulations (for details, see Section II. Privacy Policy). TASSO e.V. assumes no liability for the accuracy of the transmitted data. This data is not verified.

Confirmations

3. Once the relevant data has been saved by TASSO e.V., you as a pet owner will receive a registration confirmation and a free animal ID card by mail. Dog owners will also receive a TASSO ID tag. If an e-mail address is entered in the registration application, you will also receive a confirmation e-mail. This e-mail will list all the pet and owner information you provided during registration. This allows you to clearly see the information you provided and promptly report any errors to TASSO. It also allows you to attach the confirmation e-mail to your pet's records immediately after registration.

4. IMPORTANT: TASSO e.V. cannot register you if the registration application is not completely filled out and submitted. If you haven't received a confirmation by e-mail or by mail within four weeks of submitting your registration application, you can check online at www.tasso.net/Transponderabfrage to see if your animal has already been registered. Alternatively, please contact TASSO e.V. on weekdays between 10 a.m. and 6 p.m. to ensure that your animal has been properly registered.

Changes

5. If you, as a pet owner, transfer or sell your animal, the new owner must provide TASSO e.V. with the current owner information as soon as possible. Ideally, this should be done directly by the new owner to ensure the animal is fully protected. If new ownership is not reported to TASSO e.V., or if the change of registration

is still pending, this may result in a lost animal being returned to its previous owner. Without current owner information, we cannot return the found animal.

6. If the animal has died, this should also be reported as soon as possible.

Revocation

7. As a pet owner, you have the right to revoke your pet's registration with TASSO e.V. at any time. Please note, in particular, section 6 of the privacy policy. To revoke your registration, simply write to TASSO e.V. or send an e-mail to info@tasso.net.

II. Privacy Policy

With the following general information and mandatory data protection information, we would like to provide you with a simple overview of how your personal data is processed by TASSO e.V. and what rights you have under applicable data protection laws. Personal data include all data that can be used to personally identify you.

1. Who is responsible for processing my personal data?

2. Who can I contact if I have questions about the processing of my personal data?

3. What data does TASSO e.V. process when I register my pet?

The data provided, which is collected and used by TASSO e.V., includes the first and last name, the address of the respective animal owner and, if provided, the associated telephone number, mobile number and e-mail address, as well as the data provided to identify the respective animal.

4. On what legal basis does TASSO e.V. process my personal data?

a) Contract initiation or contract fulfillment in accordance with Art. 6 (1) (b) GDPR – This includes the registration and assistance with the reunion of lost animals; dispatch of the animal ID card and ID tag; confirmation of the registration via e-mail; change confirmations and information following a change of owner via e-mail and/or by post.

b) Consent in accordance with Art. 6 (1) (a) GDPR – This includes data processing that may only take place with your consent, for example, the disclosure of data to the finder such as the owner's last name, first name, telephone number, and possibly the address of the animal owner for the purpose of quickly returning a lost animal. This includes private individuals, animal welfare organizations, animal shelters, veterinary practices and authorities that found the animal.

5. What rights do I have regarding data protection?

You have the right to obtain information about your data stored with us, as well as further information and a copy of the data, in accordance with Art. 15 GDPR. According to Art. 16 GDPR, you have the right to rectification of your stored data if it is incorrect or incomplete. According to Art. 17 GDPR, you have the right to have relevant data deleted promptly upon request, i.e., you can request that the data in question be deleted immediately. If legal retention periods or a legitimate interest on our part (e.g. for the defense of legal claims) oppose deletion, you can alternatively request restriction of the processing of your data pursuant to Art. 18 GDPR. You have the right to data portability, i.e., you can request to receive the data you have provided to us in a structured, common, and machine-readable format, in accordance with the requirements of Art. 20 GDPR, and to transmit it to another controller. Based on the right to lodge a complaint pursuant to Art. 77 GDPR, you have the right to file a complaint with the competent supervisory authority:

If you have a complaint, we would appreciate it if you would contact us first (see point 2).

6. When can I withdraw my consent to the processing of my data?

You have the right to withdraw your consent to the processing of your personal data at any time, provided that the processing is based on Art. 6 (1) (a) (consent) or Art. 9 (2) (a) (consent to the processing of special categories of personal data) GDPR. This also applies to the withdrawal of declarations of consent that you gave us before the GDPR came into force. However, the withdrawal only takes effect for the future. Processing of your personal data that occurred before the withdrawal is therefore not affected.
